## **NDEO Seeks K-12 Dance Teachers**

## **Racial Equity Seed Fund for Boston Schools**

The **Racial Equity Seed Fund** supports an action-based learning community designed to build the capacity of Boston Public Schools to understand, implement and shape conditions that disrupt and dismantle racial inequities. **EdVestors** is recruiting six BPS schools for a 2-year networked improvement community focused on equitable literacy. Schools will receive up to \$10,000 this year (with potential for future funding) as well as support from EdVestors, BPS, Boston University and each other.
